Participation in any activity held by NHSC is entirely voluntary.

If at any point, you feel uncomfortable participating, please inform the instructor/coach present, and remove your child (or yourself) from current play. Please contact the club president for further discussion on the best course of action for proceeding.

#### Explanation:

This policy covers a phased return to play following an established outbreak of COVID-19. <u>These phases</u> are the recommendations made by sports governing and sanctioning bodies including US Youth Soccer and PA-West.

Please note that NHSC pays close attention to the mandatory federal, state, and local governmental regulations and/or recommended guidelines published by the various authority sources including but not limited to PA West and US Youth Soccer as the minimum action to be taken. As such, NHSC reserves the right to take more conservative action than is outlined in these guidelines as the club monitors policies made by governmental health agencies such as the U.S. Center for Disease Control and Prevention (CDC), Pennsylvania Department of Health and other county/local authorities.

<u>Pre-Phase</u>: Individual and virtual training. This phase includes individual fitness and technical work for players at home and with family members or with teammates via virtual solutions.

<u>Phase One</u> (1st 14 days of Green Phase): Intra-club activity. Training and small-sided in-house activities. This phase includes small-group training within teams and small-sided games within teams.

<u>Phase Two</u> (15 days of Green Phase): Intra-club activity. Small-sided games between teams within the clubs may be introduced in addition to training and SSG within teams.

<u>Phase Three:</u> Inter-club and Intra-club activity. Training, small-sided in-house games and small-sided inter-club games (within the same county).

Phase Four opens to include full size matches and travel beyond county limits.

Movement from each phase to the next is dependent on the club remaining COVID-free for a minimum of two weeks. Should a case of COVID-19 occur within the NHSC including any player, coach, immediate family member, club admin and volunteer, or if any one of the aforementioned persons comes in contact with someone with COVID-19 during any phase, NHSC will consult with the Allegheny County Health Department and PA West and suspend activity as necessary and by the guidance of health officials. Suspended play will resume no less than two weeks later and only once the club has determined facilities are safe and there is no longer a risk to members.

#### Appendix A: Action Plan for Positive Result

This plan is to provide the basis for a possible COVID-19 case in the club. This plan will identify the minimum steps that will be taken by NHSC after being alerted to a possible COVID-19 case.

- 1. <u>Before possible infection</u>:
  - a. A plan to provide information about all participants and attendees to aid tracking.
  - b. A plan for training and games to minimize exposure and spread through staggered starts.
  - c. A plan that outlines a notification process.
  - d. A plan to assess all participants prior to all activities.
  - e. A plan for adjustments to training schedules if notified of possible exposure. Instruct all coaches/admin on the assessment plan. Notify all participants and parents of the club plan.
- 2. After reported positive infection:
  - a. North Hills Soccer Club will cease and desist all activities scheduled by the club for a minimum of 2 weeks.
  - b. Remind the exposed or ill player or parent of the CDC self-isolation instruction and the need to contact their physician.
  - c. Notify the Ross Township Department of Public Works that a positive test result has been reported, to include but not limit to the location of the field affected.
  - d. Notify the county health department of the exposure or illness and confirm necessary steps.
  - e. Follow the county health department direction on notification of all individuals with possible exposure.
  - f. Redouble disinfecting measures at all affected facilities and equipment. Institute adjustments to training schedules.
  - g. Respect individual's confidentiality.

This policy is subject to change based upon seasonal scheduling and new information. We follow all mandatory precautions recommended by the CDC, PA and Allegheny Departments of Health, and PA-West. Any changes to this policy will be communicated to the club accordingly.

#### Explanation:

This policy is based upon mandates set forth by the <u>Allegheny County Health</u> <u>Department</u> and is subject to change. Please see the NHSC website for the most current version. Updates will be communicated via email and social media. **NHSC reserves the right to cancel any event if social distancing and PPE requirements are not followed.** 

#### Field Usage:

- 1. U6: U6 training will be held at Reis Run Soccer Complex
- 2. **U8**: U8 training and games will be held at community parks, as assigned
- 3. **U9/10**: U9/10 training will be held at at community parks, as assigned, with games scheduled at Reis Run Soccer Complex
- 4. **U12**: U12 training will be held at community parks, as assigned, with games scheduled at Reis Run Soccer Complex
- 5. **U13 and older**: All training for age groups U13 and up will be held at community parks and/or Reis Run Soccer Complex, as assigned, with games scheduled at Ross Elementary School

#### Spectators:

Spectators will be permitted at practices and games using the following formulas:

- 1. 1 spectator per player per practice
- 2. 2 spectators per player per game for team rosters  $\leq$  15 players
- 3. 1 spectator per player per game for team rosters > 15 players

#### Communication:

It is critical that ongoing communication be shared in order to ensure this policy and appendix are adhered to for mitigation efforts of the COVID-19 pandemic.

- 1. Communication will be provided to the NHSC club membership via email and social media.
- 2. Communication will be provided to outside/ district clubs via email
- 3. Ongoing Communication will be provided by NHSC coaches to opposing coaches on a weekly basis.
